

Booking Conditions

Bookings are only accepted on the understanding that you agree with our terms and conditions. Any breach of the rules will result in instant ejection from the property, forfeiture of the bond and a demand of payment for any damages beyond the value of the bond along with police involvement, if necessary. In addition, Nandewar Hunting will refuse to take any future bookings from all members of your party to hunt and notify other hunting enterprises, advising of the ban. There are no second chances.

While all bookings are taken in good faith, Nandewar Hunting cannot guarantee the availability of game or be held responsible for prevailing weather conditions. **No refunds or credits will be given.**

Payments:

1. **Booking Fee:** All bookings are accepted on completion of payment of a 50% deposit. The Booking Fee is non-refundable and non-transferable. Payments are made by direct credit to National Australia Bank BSB: 082 454 Account No.: 28123 2739. Use your last name as the payment Reference.
2. **Payment:** All final payment shall be paid upon arrival at Nandewar Hunting. Final payments must be paid in cash notes or money order only.
3. **Bond:** A bond of \$500 shall be paid by a hunting individual or group to Nandewar Hunting pending the satisfaction by Nandewar Hunting that the visit was concluded with all property undamaged, all structures and facilities in the same state and condition and all waist and rubbish removed. Nandewar Hunting may accept credit card details which, if required, will be charged the bond fee.

Conditions:

1. Arrival and departure must be between 7:00am and 6:00pm.
2. No spot lighting is permitted from vehicles.
3. All structures and facilities are to be left in the same state and condition as at arrival.
4. Damages beyond the value of the Bond will result in a demand for payment.
5. All waist and rubbish, including cigarette butts, to be removed at departure from Nandewar Hunting.
6. A booking form must be completed by every visitor and delivered to Nandewar Hunting.
7. A Release and Assumption of Risk form must be completed by every visitor and delivered to Nandewar Hunting.
8. Vehicles must remain on formed roads and tracks.
9. The speed limit on the property is 20km/h.
10. Visitors must hunt or travel around the property in groups of at least two people.
11. Care is to be taken when shooting near property boundaries. No shooting over boundary fences and onto neighbouring properties.
12. There are no limits on the amount of pigs, foxes, cats, hares or rabbits culled.
13. There is a limit of two goats per hunter permitted.
14. No deer are to be shot without permission from Nandewar Hunting.
15. Avoid disturbing cattle and sheep that are grazing in the area.
16. No chainsaws are allowed on the property.
17. Prices and conditions are subject to change without notice.
18. Nandewar Hunting reserves the right to postpone or cancel bookings at any time.
19. Nandewar Hunting reserves the right to not accept a booking without giving a reason.
20. All fees and charges are non-refundable and non-transferable and no credit will be given.
21. Solar powered security cameras may be installed and active around the property. Be aware that you may be filmed during your stay but this is for personal security reasons.
22. Current Shooters License and, if required, SSAA membership and credit card must be presented on arrival and prior to access.
23. No shooting of kangaroos, wallabies or other native species .

Release and Assumption of Risk

I understand that during my participation in hunting, I may be exposed to a variety of hazards and risks, foreseen or unforeseen, which are inherent in hunting and cannot be eliminated. These inherent risks include, but are not limited to, the dangers of serious personal injury, property damage and death from exposure to the hazards of travel, using firearms and bows and arrows and Nandewar Hunting has not tried to contradict or minimize my understanding of these risks. I know that injuries and damages can occur by natural causes or activities of other persons and animals, either as a result of negligence or because of other reasons. I understand that risks of such injuries and damages are involved in hunting and I appreciate that I may have to exercise extra care for my own person and for others around me in the face of such hazards. I further understand that on this visit to Nandewar Hunting there may not be rescue or medical facilities or expertise necessary to deal with the injuries and damages to which I may be exposed.

In consideration for my acceptance as a participant on this hunt, and the services and amenities to be provided by Nandewar Hunting in connection with the hunt, I confirm my understanding that:

1. I have read any rules and conditions applicable to the hunt made available to me; I will pay any costs and fees for the hunt; and I acknowledge my participation is at the discretion of Nandewar Hunting.
2. The hunt officially begins and ends at the entrance to the property Towarra. The hunt does not include transportation and I am personally responsible for all risks associated with travel.
3. This Agreement is intended to be as broad and inclusive as is permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.
4. To the fullest extent allowed by law, I agree to **WAIVE, DISCHARGE CLAIMS, AND RELEASE FROM LIABILITY** Nandewar Hunting, its officers, directors, employees and agents from **any and all liability** on account of, or in any way resulting from injuries and damages, even if caused by negligence of Nandewar Hunting its officers, directors, employees and agents, in any way connected with this hunt. I further agree to **HOLD HARMLESS** Nandewar Hunting, its officers, directors, employees and agents from any claims, damages, injuries or losses caused by my own negligence while a participant on the hunt. I understand and intend that this assumption of risk and release is binding upon my heirs, executors, administrators and assigns, and includes any minors accompanying me on the hunt.
5. I have read this document in its entirety and I freely and voluntarily assume all risks of such injuries and damages and notwithstanding such risks, I agree to participate in the hunt.
6. I have read, I understand, and I agree to the enclosed Nandewar Hunting Terms and Conditions.
